## **1. GENERAL PROVISIONS**

### 1.1.

The Administrators of personal data collected via the Online Store are ZDZISŁAW DZIURKOWSKI and JERZY ROTT, jointly conducting economic activity under a civil law partnership agreement under the name PRIMA-TECH ZDZISŁAW DZIURKOWSKI JERZY ROTT S.C. (address of principle office and mailing address: ul. Górna 2a, 42-262 Poczesna, Poland) NIP [tax identification number] 9491922250, REGON [national statistical business entity number] of civil law partnership 240040924, e-mail address: primatech@op.pl. Zdzisław Dziurkowski and Jerzy Rott are entered into The Central Registration and Information on Economic Activity of the Republic of Poland maintained by the minister for economy under the following numbers NIP [tax identification number] 5791066014, REGON [national statistical business entity number] 192864036 and NIP [tax identification number] 5731054510, REGON [national statistical business entity number] 151549163 - hereinafter referred to as "the Administrator" and at the same time being the Service Provider of the Online Store and the Seller.

### 1.2.

Personal data of the Service Recipient (Customer) is processed in accordance with the personal data protection act of 29 August 1997 (Dz. U. [Journal of Laws] No 133, it. 883 as amended) and the act on electronic services of 18 July 2002 (Journal of Laws No 144, it. 1204 as amended).

### 1.3.

The Administrator shall exercise utmost care in order to protect the interests of the persons who the data is related to, and, in particular, guarantees that the data collected is processed in accordance with the law; collected for identified, legitimate purposes and not further processed contrary to these purposes; substantially correct and adequate in relation to the purposes for which it is processed and stored in the form which permits identification of the persons it relates to, for no longer than it is necessary to achieve the purpose of the processing.

### 1.4.

Any words, phrases and acronyms appearing on this page and starting with a capital letter (e.g. Seller, Online Store, Electronic Service) shall be construed in accordance with their definitions included in the Terms and Conditions of Use of the Online Store available at: <http://www.maszynownia.info.pl/regulamin>.

## **2. PURPOSE AND SCOPE OF DATA COLLECTION**

### 2.1.

The purpose of the collection of personal data by the Administrator is:

2.1.1. The establishment, content modification, amendment to, execution or termination of a contractual relation between the Service Provider (Seller) and the Service Recipient (Customer) consisting in the provision of Electronic Services via the Online Store or the conclusion and performance of Agreement for the Sale of the Products and their delivery to the Customer.

### 2.2.

Recipients of personal data:

2.2.1. In the case of a Customer who selects in the Online Store the method of delivery by post parcel or courier parcel, the Administrator shall make the Customer's personal data collected available to

the extent that, and for no longer than it is necessary to effect the delivery, to the selected carrier performing shipment on behalf of the Administrator.

### 2.3.

The Administrator processes the following personal data of the Service Recipients (Customers): name and surname; e-mail address; contact phone number; address (street, house number, flat number, postcode, city, country). In the case of the Service Recipients (Customers) that are not consumers at the same time the Administrator in addition processes the company name and tax identification number (NIP).

### 2.4.

Providing personal data referred to in it. 2.3. is necessary for the provision of Electronic Services by the Service Provider as part of the Online Store or the conclusion of the Agreement for the Sale of the Products. Each time the scope of the required data is indicated in the Terms and Conditions of Use of the Online Store and before the provision of a particular Electronic Service or the conclusion of the Sale Agreement on the website of the Internet Store.

## **3. OPERATIONAL DATA**

### 3.1.

The Service Provider also processes anonymised operational data (the so-called logs - IP address, domain) to generate statistics facilitating the administration of the Online Store. These data are cumulative and anonymous i.e. they do not contain characteristics identifying visitors to the website of the Online Store. Logs are not disclosed to third parties.

## **4. BASIS FOR DATA PROCESSING**

### 4.1.

Personal data is provided voluntarily by the Service Recipient/Customer, however, failure to provide personal data indicated in the Terms and Conditions of Use which are necessary for the conclusion of the Sale Agreement or the agreement for the provision of Electronic Services results in the refusal to conclude the agreement. The data necessary for the conclusion of the Sale Agreement or the agreement for the provision of Electronic Services are also in each instance indicated on the website of the Online Store.

#### 4.2.

The basis for the processing of personal data of the Service Recipient/Customer is the necessity to perform the agreement, to which the Service Recipient/Customer is a party or to take action on their request before its conclusion.

### **5. CONTROL OF ACCESS TO PERSONAL DATA AND THE RIGHT TO CORRECT IT**

#### 5.1.

The Service Recipient has the right to access their personal data and to correct it.

#### 5.2.

Any person shall have the right to control the processing of the data relating to them, contained in the Administrator's data set, and, in particular, the right to: request additions, updates, rectification of personal data, temporary or permanent suspension of their processing or deletion of them if they are incomplete, no longer up-to-date, inaccurate or have been collected in violation of the law or are no longer useful to carry out the purpose for which they have been collected.

#### 5.3.

In the case of the processing of data for the purpose of direct marketing of the Administrator's own products or services, the person who the data relates to is also entitled to lodge a written, justified request to cease the processing of their data because of their particular situation and to object to the processing of their data.

#### 5.4.

## 6. FINAL PROVISIONS

#### 6.1.

The Online Store may contain links to other websites. The Administrator recommends that before going to other websites users become acquainted with a privacy policy established there. This privacy policy applies only to this Online Store.

#### 6.2.

The Administrator applies technical and organisational measures ensuring the protection of the processed personal data relevant to the risks and categories of protected data and, in particular, protects the data against their disclosure to unauthorized parties, interception by an unauthorized person, processing in violation of the legal provisions in force and the alteration, loss, damage, or destruction.

#### 6.3.

The Service Provider enables access to the following technical measures preventing the acquisition and modification by unauthorized persons of personal data sent electronically:

6.3.1. Securing the data set against unauthorized access.

6.3.2. Access to an account only after typing in a personal login and password.
